Dr. Dewakar Goel comes from a Police family, so it is but natural to evoke 'natural curiosity' in him to understand the term in its correct perspective.


He has deliberated the topic in detail, has divided the Book in eleven Chapters; discussed every Chapter and has supported it with settled case-laws at the end of each Chapter.




